

SWISS SURFING WEEK 2009

TERMS AND CONDITIONS

BOOKING

The Swiss Surfing Week is an Event organized by WaveXperience exclusively for the Swiss Surfing Association. The participation at the Swiss Surfing Week (SSW) is exclusive to active Swiss Surfing Association members.

Booking of the Swiss Surfing Week, although carried out through the SSA website, is directly with WaveXperience. The SSA acts only as an agent and does not take any responsibilities regarding booking or camp related issues.

Booking of the bus transport to and from the WaveXperience camp is through an external provider. Neither SSA nor WaveXperience take responsibilities regarding booking or transport related issues.

Rebooking involves a surcharge of 20€ and depends on availability.

PAYMENTS

The registration is not confirmed until the payment of the total amount due was received by WaveXperience. The participant pays for arising fees of transaction. Banking details are given in the registration confirmation e-mail.

PARTICIPATION CONDITIONS

Registration with complete personal information is obligatory for each participant.

Minimum age of participation is 16 years based on the first day of the SSW. Participants under 18 years of age have to send a form signed by their parents or tutor. Form is provided by WaveXperience.

Minors (under eighteens) have to obey and listen to the instructions of Wavexperience personnel. Deliberate misbehaviour and disobeying the established rules will result in a warning and contacting the parents or tutors. In case of a repetitive misbehaviour the result will be the

exclusion of the camp in which case no money will be refunded and no responsibilities for further upcoming costs will be taken.

The participant is required to help with camp duties (kitchen) once during his stay.

The participant confirms that his health permits the practice of the sport of surfing. Any information regarding possible impediments that might suppose a threat to the participant has to be communicated to WaveXperience.

The participant is responsible of WaveXperience's equipment during its use. The participant has to pay for the loss or the damage of equipment.

A 25€ deposit in cash is required per person on the day of arrival to the Camp. This deposit is refunded on the check out day if the tent is returned clean and in the same conditions as received.

The excursions and trips Wavexperience offers are not included in the total camp price. Availability depends on a minimum number of participants.

CANCELATIONS

75% of the total amount is refunded, if the cancellation is made more than one month before the start of the SSW (19.9.2008).

50% of the total amount is refunded, if the cancellation is made more than 2 weeks before the start of the SSW (19.9.2008).

No refund is made if the cancellation is made less than 2 weeks before the start of the SSW (19.9.2008).

RESPONSIBILITIES

WaveXperience dos not accept any responsibilities and will not refund money in the following circumstances:

- When the client is responsible for the incorrect delivery of the services.
- When the services can not be provided due to third parties or due to [force majeure](#).
- When happenings occur outside the camp, during the travel to and from the camp or outside of surf course schedule.
- When damage occurs because participants did not follow the instructions of WaveXperience personnel.

PRIVACY

Registration information or any information given to WaveXperience or SSA by the participant will not be shared with third parties.

INSURANCE

The participant is responsible for his health insurance and accident insurance.

CONTRACT CONCLUSION

By sending the registration information you accept the previous terms and conditions.
